1. CALL TO ORDER

Commissioner Donna McBride called the meeting to order at 1:35 PM. Quorum present.

2. WELCOME/INTRODUCTIONS

Commissioner Donna McBride welcomed attendees and asked the Commissioners, guests and staff to introduce themselves.

3. APPROVAL OF MINUTES

Meeting minutes from December 16, 2020 were reviewed. **Commissioner Donna Martin** moved to approve the minutes with the addition of the missing names. **Commissioner Robert Ashcraft** seconded the motion. The motion was unanimously approved.

4. Updates

- **AmeriCorps Director Emily Litchfield** provided an AmeriCorps Program Update. The National Competitive application process has closed and award notifications are anticipated mid-May. Thank you to commissioners and staff who assisted in program outreach as this yielded more applications than last year and should have a similar effect on the State Formula process. Staff are continuing to prioritize training for current AmeriCorps grantees particularly in the areas of partnership development and performance measurement.
- **AmeriCorps Training Administrator Randy George** provided an update on the 11th Annual Summit on Volunteerism & Civic Engagement. The Summit will be held virtually March 15 – 18, 2021 featuring workshops in the areas of National Service, Community Volunteerism and Innovative Community Solutions. Announcements regarding registration will be forthcoming from GOYFF and there is no cost to attend.
- **Commissioner Robert Ashcraft** provided an update on the Service Enterprise Initiative (SEI) sustainability planning work. Work is continuing on transitioning administration of SEI to ASU Lodestar Center with an exploration of what is working in other states and what successes Arizona has seen over the last three years. A more concrete sustainability plan will be introduced at the March commission meeting.
- **Zanquetta Gray**, Senior Portfolio Manager at the Corporation for National and Community Service (CNCS) provided an update from the AmeriCorps federal agency. The federal agency is in a time of transition for agency leadership with the new incoming administration. Initial announcements should be made in the next few days. Regional Office staff are not affected by these changes.

5. Business

- **Donna McBride** facilitated a discussion regarding the 2019-2021 Commission Strategic Plan. Commissioners reviewed the current goals and objectives and discussed items to be removed, revised or added. Of note is 1) adapting language relative to the current status of the Service Enterprise Initiative, 2) incorporating an objective and action steps regarding supporting nonprofits as they adapt to changes in volunteer management and 3) better leveraging commissioner skills and expertise to support current program expansion and new program development.

7. Next Commission Meeting:

The Commission will meet again on Wednesday, March 24, 2021 at 1:30 PM. The primary purpose of the meeting will be to review and discussed proposed additions and changes to the commission strategic plan.

A motion was made for adjournment by **Commissioner Thomas Winkel**. The motion was seconded by **Commissioner Michael Hammet**. The meeting was adjourned at 3:20 PM.
