



Mission

Part C Early Intervention builds upon and provides empower and supports families capacity to and resources to assist family members and caregivers to enhance children's learning and development through everyday learning opportunities.



Key Principles

- 1. Infants and toddlers learn best through everyday experiences and interactions with familiar people in familiar contexts.
- 1. All families, with the necessary supports and resources, can enhance their children's learning and development.
- 2. The primary role of a service provider in early intervention is to work with and support family members and caregivers in children's lives.
- 3. The early intervention process, from initial contacts through transition, must be dynamic and individualized to reflect the child's and family members' preferences, learning styles and cultural beliefs.
- 4. IFSP outcomes must be functional and based on children's and families' needs and family-identified priorities.
- 5. The family's priorities, needs and interests are addressed most appropriately by a primary provider who represents and receives team and community support.
- 6. Interventions with young children and family members must be based on explicit principles, validated practices, best available research, and relevant laws and regulations.







Evaluation and Eligibility

Arizona Early Intervention Program (AzEIP)

- 50% developmental delay in one or more developmental domains (Cognitive, Communication, Adaptive, Social-Emotional, and Motor)
- Established Condition (Medical records with a diagnosis)
- Informed Clinical Opinion

Arizona Schools for the Deaf and the Blind (ASDB)

- Bilateral vision loss
- Unilateral or bilateral hearing loss


Division of Developmental Disabilities (DDD)

- Cerebral Palsy
- Epilepsy
- Autism Cognitive/Intellectual
- Down Syndrome
- At risk for any of the above



Team Based Early Intervention

- All team members have general knowledge of infant/ toddler development
- The team determines the best fit for Team Lead (TL) based upon the families priorities
- Therapist may have specialized skills (feeding, sensory, mental health)
- If the TL needs support from another therapist, then coaching and / or joint visits occur

Division of Developmental Disabilities

All children and families receive a Service Coordinator who assists and enables an infant or toddler with a disability and the child's family to receive the services and rights required under IDEA Part C. Children eligible for AzEIP may also be eligible for DDD. DDD provides service coordination for children with AHCCCS or ALTCS insurance.


