# Families Deserve More...A Broader View

Each year the Family Reunification Day Committee would reflect on the impact of Family Reunification Day – not because of the event itself, but because of the courage, strength, honesty and hope that each family shared. We are inspired to do more.

Knowing strong families make strong communities we asked:

- How can we elevate their powerful messages. All families struggle from time-to-time, regardless of circumstance. There is hope and there are connections.
- How can we share that there are *thousands* of families in Arizona where family reunification was the proper outcome?
- How can we celebrate and honor all reunified families, not just those that happen to be nominated for Family Reunification Month?
- How can these families be better served in a more real-time manner?
- How we can share what we know with other counties in Arizona?

# Inspiration to Action – Committee Framework

## Purpose

Reunification heals families and nourishes those working within the Child Welfare System. We support positive, long-lasting permanency outcomes by harnessing the power of parent participation. We will co-create a better Child Welfare experience that prevents re-entry by joining parents with lived experience.

## Principles

We come to this work with hope and heart. Family voices are central to our work. We must team with reunified families to co-create a psychologically safe forum for parents to share their concerns and express their needs. We must actively cultivate a community reflective of the larger AZ community in all its diversity, remaining culturally humble as we do so. We must acknowledge the pervasive impact of trauma upon generations of people and communities.

# Vision for Arizona's Reunified Families

## Reimagine Family Reunification and Community Support

- All reunified families feel care and support.
- Increased empathy and understanding in our community – applause not stigma.
- Leveraging the strength and hope of the reunification community to help families stay together and provide inspiration for those families in the reunification process.
- Collaboration between stakeholders that is an evergreen support channel.
  - Working with Foster Arizona to include a Reunified Family community within Foster Cooperative
- On-going recognition of these inspirational families, not just during Family Reunification Month, but all year long. Connecting with families as they reunify.
- Family Reunification is celebrated statewide.
